Business Arising from the Minutes

Event Debriefs

- Earth Day April 26, 2025:
 - Earth Day event was well-attended, started early in the morning.
 - o \$965 worth of sales were made, which is down from previous years.
 - Sold 50 blue boxes, 9 black composters, 7 green cones, and 15 rain barrels.
 - People inquired about where to get grease collector containers and accelerator for the green cones – Municipal Office.

- Vegetables and breads were given away Mary Jane from Cycle of Life was thanked for her contribution.
- Act On Litter Day May 5, 2025:
 - Approximately 130kg of litter was collected. It was suggested that the Township encourage residents to pick up litter on Litter Day and that the Township provide garbage bags and tags to people who volunteer to pick up litter.
 - Concerns were raised about people taking advantage of the offer. Last year, it
 was suggested that if people put the litter in clear bags, then the Township
 could pick up the bags and would recognize the contents as being roadside
 garbage/litter.
 - Clerk Julie Middleton advised that she would speak with Works Superintendent Adam Prouse about this.

SWOX Township Fare Event

The Committee reviewed the draft floor plan and proposed scavenger hunt and noted the following:

- The event is scheduled for May 24th. Setup will take place on Friday, May 23rd at 3:00 p.m. There are over 40 vendors registered for the event. The layout for outside will still need to be confirmed (i.e. Food Trucks, Little Hobby Hill Farm, Dog Training).
- Ox on the Run may also be present.
- Nicole will contact the vendors that are registered in advance of the event to advise them:
 - About setup times to start at 10:00 a.m. Julie will be there around 9:00 a.m. on Saturday.
 - Vendors may host their own door prize draws as long as it is at no cost and available to everyone.
 - Vendors should park their vehicles at the back of the parking lot or in the over flow parks south of the park after they have unloaded and set up.
 - Vendors scavenger hunt will take place vendors will be provided with stamps? Or pens to initial on the scavenger hunt sheets. Staff to confirm if all registered vendors are on the scavenger hunt?
 - Township will provide prizes for scavenger hunt candy bags?
- Township committees will have a prize for signing up for the Township e-Newsletter and then name will be entered into the draw prize to be blue box and recycling bin and other donated prize?
- The goal of the event is to raise community awareness of local businesses.
- A questionnaire will be given to vendors following the event to gather feedback on the event. Questions will include what was done right, what could be improved, and interest in future events.
- The committee is considering making the event an annual occurrence same weekend in May in 2026. Information regarding the 2026 Municipal Election should be shared if the event continues into 2026.

SWOX Talks and Village Voice

The Committee reviewed the monthly newsletters and Village Voice ads for April, 2025.

Discussion Items

<u>Wind Turbine Proposals – Community Engagement and Communication</u>

The Committee engaged in extensive discussion regarding two proposed wind turbine projects within the Township: Bower Hill Wind Farm and Cedar Flats Wind Farm, brought forward by ProWind and WPD Corporation, respectively. Members reviewed the community consultation processes currently underway for both proposals.

It was explained that the proponents are required to consult with both the Township and the public before submitting their applications to the Independent Electricity System Operator (IESO) and before seeking a municipal resolution of support.

Should a proposal be approved by the IESO, the company must then apply for a zoning bylaw amendment and obtain site plan approval from the Township prior to being eligible for a building permit.

The Committee suggested that the Township's communications with the public focus on outlining the process and directing residents to information made available by the proponents. It was emphasized that these proposals are not initiated by the Township.

It was further noted that, Council will need to carefully consider all relevant information, including public input, the potential benefits to the broader community, individual property rights, and any demonstrated impacts of the proposed developments.
